If no original invoice can be produced, the warranty will be considered to be valid from the production week (DOT). The maximum duration of the warranty is 60 months from DOT.

Applicable Tires:

- Tractor tires
- Harvester tires
- Agri-industrial tires
- Implement tires
- Small agricultural tires
- Lawn- and ground care tires

Any credit due to these warranty conditions will be credited against the original purchase amount or retail selling value, calculated according to the duration of use or age and wear, as shown in the schedule below. Any direct or indirect expenses such as mounting or freight will not be paid. Vredestein will determine the duration of use or age and wear. These findings represent the only basis for the warranty credit.

No Credit will be issued for:

- Damage due to excessive or insufficient tire pressure
- Damage due to improper fitting or projection cuts
- Irregular or rapid wear due to mechanical irregularities in the vehicle itself or a vehicle towed by it, such as incorrect wheel alignment
- Incorrect storage or transport and weather-related damage
- Vandalism

Stubble Damage coverage:

In addition to the Standard Warranty related to the general Sales conditions, this extended Stubble Damage Cover under this Warranty Policy covers all new Vredestein brand Agricultural tires, and which are used in typical agricultural operations.

If, in a typical / normal agricultural operation, a tire becomes unserviceable or irreparable as a direct result of stubble damage, a pro - rata adjustment / credit will be awarded towards the replacement of the unserviceable tire with a comparable new Vredestein tire. The pro - rata adjustment calculation will be determined against the current purchase price of the tire that is applicable at the time of adjustment.

If, in a typical / normal agricultural operation, a tire becomes unserviceable or irreparable as a direct result of Field Hazard damage, a pro - rata adjustment / credit will be awarded towards the replacement of the unserviceable tire with a comparable new Vredestein tire. The pro - rata adjustment calculation will be determined against the current purchase price of the tire that is applicable at the time of adjustment.
