

# Vredestein Promotion

## Terms and Conditions

1. The “Vredestein” (the “Promotion”) is open to all consumers who are residents of the United States, aged 18 and over except employees of Apollo Tires (US) Inc (the “Promoter”) and its agencies or anyone else connected with the creation and administration of the promotion.
2. Limited time offer available on purchase of 4 qualifying Vredestein tires purchased in participating stores. This promotion will run from August 1st to August 31st 2024.
3. Purchase is necessary to qualify for reward offered. The offer is open to retail customers who purchase any four Vredestein tires in an approved participating store August 1st to August 31st 2024. There is a 5 day grace period on sales date either side of the promotion.
4. The offer excludes company vehicle drivers (Fleet), businesses, organizations, and institutions.
5. By participating in this Promotion, claimants agree to be bound by the terms and conditions of the promotion and by any other requirements set out in the promotional materials.
6.
